WISCONSIN SUPREME COURT MONTHLY STATISTICAL REPORT

December 2016

This statistical report presents information about the case filings and dispositions of the Wisconsin Supreme Court during the month of December 2016 and to date for the term that began on September 1, 2016.

Opinions Issued by the Court

The Supreme Court issued opinions involving 2 cases in December. Information about these opinions, including the Court's dispositions and the names of the authoring justices, can be found on the attached table.

Petitions for Review

A total of 54 petitions for review were filed during the month. A petition for review asks the Supreme Court to review the decision of the Court of Appeals. The Supreme Court's jurisdiction is discretionary, meaning that review is granted in selected cases only. In December, the Supreme Court disposed of 39 petitions for review, of which 3 petitions were granted. The Supreme Court currently has 198 petitions for review pending.

Petitions for Bypass

In December, the Supreme Court received 0 petitions for bypass and disposed of 0 petitions for bypass. In a petition for bypass, a party requests that the Supreme Court take jurisdiction of an appeal or other proceeding pending in the Court of Appeals. A matter appropriate for bypass is usually one which meets one or more of the criteria for review by the Supreme Court and one the Supreme Court concludes it will ultimately choose to consider regardless of how the Court of Appeals might decide the issues. A petition for bypass may also be granted where there is a clear need to hasten the ultimate appellate decision. The Supreme Court currently has no petitions for bypass pending.

Requests for Certification

During December 2016, the Supreme Court received 0 requests for certification and disposed of 0 requests for certification. In a request for certification, the Court of Appeals asks the Supreme Court to exercise its appellate jurisdiction before the Court of Appeals hears the matter. A request for certification is decided on the basis of the same criteria as a petition to bypass. The Supreme Court currently has 1 request for certification pending.

Regulatory Matters, Supervisory Writs, and Original Actions

During the month, a total of 10 matters within the regulatory jurisdiction of the Court (bar admission, lawyer discipline, and judicial discipline) were filed and no such cases were reopened. The Supreme Court also received 5 petitions for supervisory writ, which ask the Supreme Court to order the Court of Appeals or a circuit court to take a certain action in a case. No original actions were filed. An original action is a petition asking the Supreme Court to take jurisdiction over a particular matter. When an opinion is issued in these cases, the disposition is included in “Opinions Issued by the Court” above; otherwise, the case is disposed of by order and is included in the totals below. The Supreme Court currently has 34 regulatory matters and 11 petitions for supervisory writ pending.
