| Purpose of Form: | <p>To submit the standardized assessment and recommendation by a qualified individual for a child/juvenile in a placement certified as a Qualified Residential Treatment Program (QRTP) and the documents were not available at the time the placement was made or hearing was held authorizing the placement.</p> <p>This form may also be used to submit the standardized assessment and recommendation by a qualified individual when a congregate care placement is not certified at the time the child/juvenile enters the placement, but subsequently becomes certified as a QRTP.</p> <p>In either event, the assessment and recommendation must be submitted no later than 30 days after the date the child/juvenile entered the placement or the placement becomes certified as a QRTP placement, whichever is applicable.</p> |
| Who Completes It: | Caseworker, district attorney, corporation counsel, or other party requesting the placement. |
| Distribution of Form: | Court, Child/Juvenile's Guardian ad Litem/Adversary Counsel, Parents, Parents' Attorney(s), Child's Guardian/Legal Custodian, District Attorney/Corporation Counsel, Caseworker, Tribe, and Indian Custodian. |
| Accompanying Forms: | The Child and Adolescence Needs and Strengths (CANS)" (i.e., standardized assessment) and the Permanency Plan Addendum for Placement in a Setting Certified as a Qualified Residential Treatment Program (QRTP) (i.e., recommendation by a qualified individual) shall be filed with this form. |
