Intervenors-Petitioners Lisa Hunter, Jacob Zabel, and John Persa have moved the court for relief from that part of its March 3, 2022 decision and order that adopted new Congressional district maps. On January 29, 2024, a motion directed to me individually seeking my recusal from participating in the court's resolution of the motion for relief was filed by Intervenor-Respondent Wisconsin Legislature; Petitioners Billie Johnson, Eric O'Keefe, Ed Perkins, and Ronald Zahn; and Intervenors-Petitioners Congressmen Glenn Grothman, Mike Gallagher, Bryan Steil, Tom Tiffany, and Scott Fitzgerald.

I decline to participate in this proceeding because I was not a member of the court when it issued its March 3, 2022 decision and order. See, e.g., Greenwald Family Ltd. P'ship v. Village of Mukwonago, No. 2021AP69-FT, unpublished order (Wis. Sept. 26, 2023) (Protasiewicz, J. not participating). The motion seeking my recusal is moot, and, thus, I do not reach the question of whether the law requires my recusal.
