No. 2023AP1399-OA      Clarke v. Wisconsin Elections Commission

On December 22, 2023, this court appointed the team of Dr. Bernard Grofman and Dr. Jonathan Cervas to serve as the court's consultants in this matter and instructed the Director of State Courts to enter into one or more retainer agreements between the court and Dr. Grofman and Dr. Cervas for their services. The Director of State Courts entered into retainer agreements with Dr. Grofman and Dr. Cervas on January 3, 2024. The court's December 22, 2023 order provided that the reasonable costs and expenses incurred by Dr. Grofman and Dr. Cervas pursuant to the retainer agreements shall be borne by the parties as determined by the court in a future order. On February 25, 2024, Dr. Grofman and Dr. Cervas submitted a statement of fees and expenses totaling \$128,158.00. Now, therefore;

IT IS ORDERED that by April 9, 2024, the parties shall inform the court, in writing, on what basis the fees and expenses of the consultants should be allocated to the parties in this matter, and why that basis is preferable over other methods of allocation.
