Five are already full parties to the pending federal redistricting suits: (1) Black Leaders Organizing for Communities et al. are federal Plaintiffs and seek to intervene as Petitioners here; (2) Lisa Hunter et al. are federal Plaintiffs and seek to intervene as Petitioners here; (3) the Wisconsin Legislature is a federal Intervenor-Defendant and seeks to intervene as a Respondent here; (4) Governor Tony Evers is a federal Intervenor-Defendant and seeks to intervene as a Respondent here; and (5) Congressmen Glenn Grothman et al. are federal Intervenor-Defendants and seek to intervene as Petitioners here.

In addition, two new sets of parties wish to intervene: (6) Janet Bewley, the State Senate Democratic Minority Leader, who seeks to intervene as a Respondent; and (7) Gary Krenz et al., who are amici in the federal action, and who seek to intervene as Petitioners here.

The Petitioners do not oppose the addition of any of the proposed intervenors as parties to this suit. The Petitioners do
