SUBJECT: To be filed in Rule Petition 12-01

Comment 2: How Justice Roggensack's Third Proposed Calendar (August 2, 2013) Would Have Worked in the Last 10 Completed Rules Petitions.

To evaluate Justice Roggensack's third proposed calendar filed August 2, 2013, it is helpful to examine how the last ten rules in which final orders were issued by the court would have fared under the proposed calendar. The first column below shows the date on which an event occurred. The second column shows the date on which an event would have occurred had the proposed calendar been in effect at that time.

In every instance, a rules petition under Justice Roggensack's August 2 proposal takes more time to complete than under the present system. The additional time ranges from 203 to 670 days.
