Re: Supreme Court Rule Petition 12-01, Judicial Rulemaking

Greetings:

The Wisconsin Supreme Court is seeking public comment on changes the court has made in the court's rulemaking function that strengthen, improve, and make more regular the rulemaking function. You have received this letter because you, your agency, or your organization have been identified as potentially having an interest in this matter or as having filed a rule petition with the supreme court in the past several years.

In May 2011 the Wisconsin Supreme Court Advisory Committee on Rule Procedures filed its report and recommendations with the supreme court. In appendix A of its report, the committee proposed rules governing the court's rulemaking process. The report and comments on the Advisory Committee's proposed rule are posted on the court's web site under Rule Petition 12-01 at http://wicourts.gov/scrules/1201.htm.

On November 28, 2012, Justice Patience Roggensack filed a rule proposal for the court's rulemaking function. Justice Roggensack proposes a calendar for establishing dates certain for filing rules petitions, for filing comments, and for court hearings. A copy of Justice Roggensack's November 28, 2012 rule proposal can be found at the court's web site under Responses to Rules Petition 12-01 at http://wicourts.gov/scrules/1201.htm.

On January 23, 2013, the court discussed the matter at an open rules conference and Justice Roggensack provided a redlined version of her rule proposal in which her changes to the Advisory Committee's rule proposal are indicated by strikethroughs and underlining. This document is also found at the court's web site under Responses to Rules Petition 12-01 at http://wicourts.gov/scrules/1201.htm.

On February 28, 2013, the court discussed the matter again and voted 4 to 3 to adopt the concept of a calendar cycle for rules matters that will identify deadlines and dates for filing and considerations of petitions, comments, and court hearings.

On June 3, 2013, Chief Justice Shirley S. Abrahamson filed an amendment to the pending judicial rulemaking petition 12-01, establishing dates certain for filing rules petitions, for filing comments, and for court hearings. A copy of Chief Justice Abrahamson's June 3, 2013 rule proposal can be found at the court's web site under Responses to Rules Petition 12-01 at http://wicourts.gov/scrules/1201.htm.

The court seeks comments on how best to implement the calendaring of rules petitions, including the time for filing rule petitions, the time for comments, and the time for court consideration of a rules petition. The court is interested in any of your comments on this matter, including comments on the following:

- how to facilitate your organization's participation in a calendar cycle for the rule making process (if, for example, your organization meets at designated times);
- alternative timelines for a calendar for rulemaking;
- how to facilitate the statutory filing and notice requirements under Wis. Stat. § 751.12 during the rules cycle;

Comments should be filed by August 16, 2013, with the Clerk of Supreme Court, Attention: Deputy Clerk-Rules, P.O. Box 1688, Madison, WI 53701-1688. If an advisory committee cannot respond by this date, an extension may be requested. If possible, e-mail a Microsoft Word version of your response to clerk@wicourts.gov. See comment guidelines at the court's website at http://wicourts.gov/scrules/petitioncomment.htm.

Following the expiration of the comment period, the court will schedule an open rules petition conference to discuss this matter further. Written comments filed with the clerk's office will be posted on the court's web site, as will court communications on this matter.
