#### Dear Petitioners:

I am assisting the Wisconsin Supreme Court with its consideration of your rule petition requesting the court amend the supreme court rules relating to referees in the Lawyer Regulation System (Rule Petition No. 13-04), which you filed on May 22, 2013. The court briefly discussed this petition in open rules conference on June 11, 2013, and requested that I seek additional information about the proposed amendments. Specifically, your response to the following issues or questions is sought at this time:

- How many hours per week do you estimate each of the four proposed referees would be required to invest on lawyer disciplinary matters?
- How many referees will be members of an auxiliary panel?
- How would an auxiliary group of referees be selected?
- What constitutes "substantial judicial or litigation experience" for purposes of the proposed rule?
- What is the anticipated nature of the "contractual arrangement" between the referees and the court?
- Should geographic considerations be part of the referee selection process?
  - o Do you anticipate increased travel time and related costs for these referees?
- How would substitution requests be handled under the proposed amendment?
- How should the court select the four referees?

- Explain how the proposal is likely to have a "beneficial fiscal impact" as stated in the Supporting Memorandum.
- Will the amendments have retroactive application?
- The court also seeks information about the current referee panel and the process for selecting and assigning referees to disciplinary cases. Please respond to the following questions:
  - o How many referees are currently on the permanent panel?
  - o What regions are they from?
  - o How many of these referees have been appointed in the past three years?
  - o How much time, on average, does a referee invest in a disciplinary case?
  - What are the average fees and costs reported by referees?
- Finally, comments from the Legislative Reference Bureau were provided by e-mail on June 3, 2013. Keith Sellen responded by e-mail on June 11, 2013, on behalf of the OLR. The joint petitioners are asked to please respond to the comments with any amendments they deem necessary. If there are no additional comments, please state that fact.

Please file your response(s) by September 30, 2013, with the Clerk of Supreme Court, Attention: Carrie Janto, Deputy Clerk, P.O. Box 1688, Madison, WI 53701-1688. If possible, e-mail a Microsoft Word version of the response(s) to carrie.janto@wicourts.gov or clerk@wicourts.gov.

The court may request further information prior to a public hearing or open rules conference. The court has scheduled this rule petition for a public hearing on Friday, October 25, 2013, at 9:30 a.m., in the Supreme Court Room in the State Capitol, Madison, Wisconsin, to discuss this matter. The court may take any action it deems appropriate, including any of the following:

- (a) Adopt the rule proposed, or a modified version, without further comment.
- (b) Reject the rule proposed without further comment.
- (c) Circulate the rule petition for comment without a public hearing.
- (d) Refer the rule petition to another entity for its review and recommendation.
- (e) Request further information or analysis from the petitioner or interested persons or entities.
