3. I am not a Wisconsin resident, nor am I regularly engaged in the practice of law or other business in Wisconsin.


4. I have not been denied admission to any state or federal court at any time.

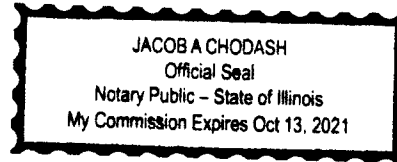


