**MOTION FOR ADMISSION PRO HAC VICE  
OF ATTORNEY RACHAEL C. TUCKER**

I, Kevin M. St. John, a member of good standing with this Court, respectfully move for the admission *pro hac vice* of Attorney Rachael C. Tucker to represent the Wisconsin Legislature in the above-captioned original action. In support of this motion, I represent as follows:

1. Attorney Tucker is affiliated with my firm, Bell Giftos St. John LLC, in that we jointly provide legal services to the Wisconsin Legislature in this matter.

2. The Legislature has moved to intervene so that it can participate as a full party in this matter. It also has moved for leave to file an amicus brief and to recuse Justice Protasiewicz.

3. Consistent with Wis. SCR 10.03(4)(b)1 and Appendix A-1 to Wis. SCR Ch. 10, Attorney Tucker has completed and submitted her *pro hac vice* application to the State Bar of Wisconsin to represent the Wisconsin Legislature in this matter. Her application is attached hereto, and the representations made therein are incorporated into this motion.

4. Attorney Tucker included in her application to the State Bar of Wisconsin fees required by Wis. SCR 10.03(4)(b)2 via credit card. Her application, attached hereto, includes proof of payment.

5. Attorney Tucker submitted a single application and fee for both this matter and *Wright et al. v. Wisconsin Elections Commission et al.*, No. 2023AP001412-OA, because the two cases are likely to be consolidated or litigated together.

WHEREFORE, I respectfully request the Court grant this motion and permit Attorney Tucker, a nonresident attorney, to appear before this Court in this matter on behalf of the Non-Party Amicus and Proposed Intervenor-Respondent, the Wisconsin Legislature.
