**Declaration Based on Noncompliance for Money Judgment Non-Eviction (Small Claims)**

**I DECLARE THAT:**

1. The parties entered into a stipulation (agreement) for dismissal on [Date] \_\_\_\_\_. The obligated party (payor) agreed to pay the payee \$\_\_\_\_\_ in full settlement of this case and the case was dismissed.
2.
