2023AP308-CRNM State of Wisconsin v. Akeem Dominique Hudson (L.C. # 2020CF3526)

Before White, C.J., Donald, P.J., and Geenen, J.

Summary disposition orders may not be cited in any court of this state as precedent or authority, except for the limited purposes specified in WIS. STAT. RULE 809.23(3).

By order dated September 8, 2023, this court directed Attorney Jeffrey W. Jensen, appellate counsel for Akeem Dominique Hudson, to file a supplemental no-merit report in this matter. Attorney Jensen now requests voluntary dismissal of the no-merit appeal and an extension of appellate deadlines to permit the filing of a postconviction motion under WIS. STAT. RULE 809.30(2)(h) (2021-22).<sup>1</sup> A no-merit appeal is appropriate only if counsel is convinced

that further postconviction proceedings would be wholly frivolous. *See McCoy v. Court of Appeals*, 486 U.S. 429, 437 (1988). Accordingly, the court will grant relief. To accommodate this court's procedures at remittitur, the court will grant an extension slightly longer than requested.

IT IS ORDERED that the no-merit report is rejected and this appeal is dismissed without prejudice. *See* WIS. STAT. RULE 809.18(1).

IT IS FURTHER ORDERED that the deadline for Hudson to file a postconviction motion or notice of appeal pursuant to WIS. STAT. RULE 809.30 is extended through November 17, 2023. *See* WIS. STAT. RULE 809.82(2)(a).

IT IS FURTHER ORDERED that this summary disposition order will not be published.
