authority, except for the limited purposes specified in WIS. STAT. RULE 809.23(3).

Roger Burrow appeals the circuit court's judgment holding that Wausau Underwriters

Insurance Company and Employers Insurance Company of Wausau have no duty to defend or

indemnify him because he was an independent contractor rather than an employee of Lake Mills

School District. We conclude in Radebaugh v. Wausau Underwriters Insurance Company, No.

16AP2357, unpublished slip op. (WI App Dec. 7, 2017), issued this same date, that Burrow is

shielded from liability under the contact sports immunity statute, WIS. STAT. § 895.525(4m)

(2015-16)¹ and the parties agree that upon our affirmance in the companion appeal, this appeal is

moot. We summarily dismiss this appeal. WIS. STAT. RULE 809.21(1). Therefore,

IT IS ORDERED that the appeal is summarily dismissed pursuant to WIS. STAT. RULE

809.21.

IT IS FURTHER ORDERED that no costs are allowed in this appeal.
