Summary disposition orders may not be cited in any court of this state as precedent or authority, except for the limited purposes specified in WIS. STAT. RULE 809.23(3).

This appeal currently proceeds under the no-merit procedure of WIS. STAT. RULE 809.32 (2015-16).¹ The appellant, by counsel, advises that an issue with arguable merit has been located and a WIS. STAT. RULE 809.30 postconviction motion is required. The motion alleges that a *pro*

se postconviction motion was filed in October 2017. Good cause is shown to dismiss this appeal and reinstate the RULE 809.30 deadline for seeking postconviction relief.

Upon the foregoing reasons,

IT IS ORDERED that the WIS. STAT. RULE 809.32 no-merit report is rejected, this appeal is dismissed, and the WIS. STAT. RULE 809.30 deadline for seeking postconviction relief is reinstated.

IT IS FURTHER ORDERED that a WIS. STAT. RULE 809.30 postconviction motion shall be filed no later than February 9, 2018.

IT IS FURTHER ORDERED that the time for deciding any WIS. STAT. RULE 809.30 postconviction motion filed before the date of this order is extended to April 6, 2018.

IT IS FURTHER ORDERED that this summary disposition order will not be published.
