2017AP617-CRNM State of Wisconsin v. Armono M. Cornelius (L.C. # 2013CF4673)

Before Neubauer, C.J., Gundrum and Hagedorn, JJ.

Summary disposition orders may not be cited in any court of this state as precedent or authority, except for the limited purposes specified in WIS. STAT. Rule 809.23(3).

Armono Cornelius appeals from a judgment convicting him of being a felon in possession of a firearm. Appointed appellate counsel filed a no-merit report pursuant to WIS.

STAT. RULE 809.32 (2015-16)¹ and *Anders v. California*, 386 U.S. 738 (1967). Cornelius received a copy of the report and filed a response.

In a letter to this court dated March 27, 2018, Cornelius advises the court that he desires to dismiss this appeal because “I don’t want to pursue my appeal anymore.” In light of this request, we will reject the no-merit report and summarily dispose of this appeal pursuant to WIS. STAT. RULE 809.21.

Upon the foregoing reasons,

IT IS ORDERED that the WIS. STAT. RULE 809.32 no-merit report is rejected.

IT IS FURTHER ORDERED that this appeal is dismissed.

IT IS FURTHER ORDERED that this summary disposition order will not be published.
