State of Wisconsin ex rel. Vincent Martinez v. Brian Hayes, Administrator (L.C. #2017CV627)

Summary disposition orders may not be cited in any court of this state as precedent or authority, except for the limited purposes specified in WIS. STAT. RULE 809.23(3).

Vincent Martinez, pro se, appeals from an order denying his petition for writ of certiorari

on the ground that his petition was untimely. Martinez argues his petition was timely and seeks a remand back to the circuit court to address his petition on the merits. Based upon our review of

the briefs and the record, we conclude at conference that this case is appropriate for summary disposition. *See* WIS. STAT. § 809.21 (2015-16).¹ We affirm the order of the circuit court.

On October 22, 2013, Martinez's extended supervision was revoked. The Division of Hearings and Appeals (Division) affirmed his revocation on November 12, 2013. On September 1, 2017, Martinez requested a new revocation hearing, which the Division denied on September 8, 2017. On November 3, 2017, Martinez filed a petition for writ of certiorari with the circuit court, which was denied by the court as untimely in its decision and final order of November 30, 2017. Martinez filed a notice of appeal on November 27, 2017.

We affirm on multiple grounds. First, Martinez's appeal was filed before the entry of the court's November 30 decision, and, therefore, Martinez's notice of appeal was defective and his appeal must be dismissed. *See Ramsthal Advert. Agency v. Energy Miser, Inc.*, 90 Wis. 2d 74, 75-76, 279 N.W.2d 491 (Ct. App 1979) ("An appeal cannot be taken from an order before it is entered.").

Second, WIS. STAT. § 893.735(2) bars a certiorari action that is commenced more than forty-five days after the cause of action accrues. A certiorari action is commenced at the time a prisoner files a petition seeking a writ of certiorari with a court. *See* § 893.735(3). The decision of the Division was on September 8, 2017; the forty-five day deadline was October 23, 2017. As

Martinez did not file his petition until November 3, 2017, his petition is time barred by § 893.735(2).²

Upon the foregoing reasons,

IT IS ORDERED that the decision and order of the circuit court is summarily affirmed pursuant to WIS. STAT. RULE 809.21.

IT IS FURTHER ORDERED that this summary disposition order will not be published.

² Martinez's argument that his deadline was tolled is without support in the record. A party seeking tolling has the burden of proof. *State ex rel. Johnson v. Litscher*, 2001 WI App 47, ¶10, 241 Wis. 2d 407, 625 N.W.2d 887.
