after revocation. Based on a review of the sentencing transcript, this court could not say that a challenge to the circuit court's exercise of discretion on sentencing would be wholly frivolous.

By order dated October 29, 2021, we directed counsel to consult with Nero and either: (1) submit a written statement from Nero indicating that he wished to waive any challenge to the court's exercise of discretion on sentencing and that he understands the consequences of his waiver; or (2) request that we dismiss this appeal in favor of an extension of time to file a postconviction motion in the circuit court.

Counsel now informs this court that after consultation with Nero, he does not wish to waive any challenge to the circuit court's sentencing discretion. Rather, Nero seeks to file a postconviction motion. We will therefore reject the no-merit report, dismiss the appeal and extend the time for filing a postconviction motion.

Upon the foregoing,

IT IS ORDERED that the no-merit report is rejected and the appeal is dismissed.

IT IS FURTHER ORDERED that the time for filing a postconviction motion is extended to January 10, 2022.

IT IS FURTHER ORDERED that this summary disposition order will not be published.
