State of Wisconsin v. James Donald Richmond (L.C. # 2019CF207)

Before Kloppenburg, P.J., Blanchard, and Graham, JJ.

Summary disposition orders may not be cited in any court of this state as precedent or authority, except for the limited purposes specified in WIS. STAT. RULE 809.23(3).

Attorney Erica Bauer, appointed counsel for James Richmond, previously filed a no-merit report seeking to withdraw as appellate counsel pursuant to WIS. STAT. RULE 809.32 (2021-22)<sup>1</sup> and *Anders v. California*, 386 U.S. 738 (1967). In an order dated March 26, 2024, this court requested additional input from counsel, after consultation with Richmond, regarding whether there is any non-

frivolous issue relating to Richmond's prior offenses.<sup>2</sup> Counsel has now responded to this court's

order with a motion to voluntarily dismiss this no-merit appeal and reinstate and extend the time to

file a postconviction motion. Counsel states that she has now concluded that an issue of merit exists

that she overlooked previously. Accordingly, we reject the no-merit report, dismiss this no-merit

appeal, and conclude that there is good cause to reinstate and extend the time to file a postconviction

motion.

Therefore,

IT IS ORDERED that the no-merit report is rejected and that this appeal is dismissed.

IT IS FURTHER ORDERED that the time to file a postconviction motion is reinstated and

extended to forty days from the date of this order.

IT IS FURTHER ORDERED that this summary disposition order will not be published.
