A motion to vacate the filing fee in this writ proceeding having been filed on behalf of petitioner, Michael B. Kingsley;

IT IS ORDERED that the motion is denied. The motion alleges that petitioner filed a petition for a writ of habeas corpus and a motion for waiver of prepayment of the filing fee in October 2014, but that he never filed any petition within 30 days. He therefore asks that the court vacate the filing fee or the waiver of the filing fee. The allegations of the motion are incorrect. The record establishes that the petitioner filed a petition for a writ of habeas corpus and a motion for waiver of prepayment of the filing fee on August 6, 2014. The petitioner filed a second motion for waiver of prepayment of the filing fee on August 15, 2014. By order dated August 19, 2014,

the court granted waiver of the prepayment of the filing fee (not waiver of the filing fee) and ordered the agency having custody of the petitioner's trust fund account to freeze his trust fund accounts and to forward partial payments of the filing fee out of the trust fund accounts until the filing fee is paid in full. Petitioner did file a petition for a writ of habeas corpus, and, based on the waiver of the prepayment of the filing fee, the court considered that writ petition. It denied the writ petition on the merits in an order dated January 13, 2015. Accordingly, there is no basis to vacate the filing fee or the August 19, 2014 order requiring the agency having custody of the petitioner's trust accounts to forward payments for the filing fee in this matter to the clerk of this court.
