On March 30, 2015, this court deemed the motion of defendant-appellant, Courtney M. Cowins, as a timely petition for review, and ordered defendant-appellant to file a statement in support of the petition that conforms to the requirements of Wis. Stat. §§ 809.62(2) and (4) with the clerk of this court by July 3, 2015, or the petition would be summarily dismissed. The March 30, 2015 order also stated that no further time extensions would be granted.

On April 22, 2015, defendant-appellant filed a letter seeking legal advice about matters he alleges are pending in the court of appeals or in the supreme court. Defendant-appellant also filed a motion entitled "Special Appearance: Motion to Vacate Judgments for Lack of Jurisdiction Pursuant to Wis. Stat. § 809.14," which appears to be a motion directed to the court of appeals.
