No. 2023XX1719-D Office of Lawyer Regulation v. Kristin Debra Lein

On October 10, 2023, the Office of Lawyer Regulation (OLR) filed a notice of motion and motion, along with a supporting brief and a supporting affidavit, seeking the summary license suspension of Attorney Lein's license to practice law in Wisconsin pursuant to SCR 22.20. The motion is based on Attorney Lein's convictions for wire fraud, engaging in a monetary transaction in property derived from a specified unlawful activity, and tax fraud. See United States of America v. Kristin Lein, United States District Court for the Western District of Wisconsin, Case No. 23-cr-43-wmc.

On October 13, 2023, this court ordered Attorney Lein to show cause, in writing, by November 2, 2023, why the OLR's motion should not be granted. Attorney Lein has not responded to the order to show cause.

IT IS ORDERED that the OLR's motion for summary license suspension is granted. The license of Attorney Kristin Debra Lein to practice law in this state is temporarily suspended as of the date of this order and until further order of this court. She shall comply with the requirements of SCR 22.26 relating to license suspension.
