The briefing schedule shall be amended as follows: The plaintiffs-appellants-cross-respondents, Christopher Waters, et al., shall file their brief or a statement that no brief will be filed by September 28, 2000; within 30 days thereafter the defendants-respondents-cross-appellants shall either file a combined response/cross-appellant brief or a statement that no brief will be filed, and the defendants-respondents, Nicholas Haus, et al., shall also file a brief or a statement that no brief will be filed; within 20 days thereafter the plaintiffs-appellants-cross-respondents shall file a combined reply to the defendants-respondents-cross-appellants and defendants-respondents' brief(s) and response; within 10 days thereafter the defendants-respondents-cross-appellants shall file a reply to the plaintiff-appellants-cross respondents' brief.
