You are hereby notified that the Court, by its Clerk and Commissioners, has entered the following order:

No. 2024AP670-LV Klatt v. City of Menomonie, L.C.#2023CV271

On April 12, 2024, this court dismissed a premature bypass petition filed by petitioner-petitioner, Brady Jon Klatt, pro se. Also on April 12, 2024, Mr. Klatt filed a motion for reconsideration of that order. In his motion Mr. Klatt argues, among other things, that "the Wisconsin Supreme Court cannot deny my petition for leave on appeal because they also have not accomplished paper service of four parties." The court notes that it is neither required nor authorized to serve papers on behalf of litigants.

IT IS ORDERED that the motion for reconsideration is denied for the same reason provided in the court's April 12, 2024 order. See Milwaukee Brewers Baseball Club v. Wisconsin Dept. of Health and Social Servs., 130 Wis. 2d 56, 62-63, 387 N.W.2d 245 (1986). To the extent that Mr. Klatt is asking this court to reconsider the April 12, 2024 order denying his petition for leave to appeal a non-final order, the court notes that order was issued by the court of appeals and this court does not have jurisdiction to reconsider it.
