Brown v. WEC, L.C.#2022CV1324

On May 3, 2024, this court entered an order that granted the petitions to bypass filed in the above-captioned matter, "assume[d] jurisdiction over the entire matter," and set forth a briefing schedule for the parties. The Wisconsin Alliance for Retired Americans ("Alliance") has moved for clarification of the court's May 3, 2024 order. The Alliance notes that it intervened as a defendant in the circuit court proceedings and timely filed a notice of appeal of the circuit court's decision, but did not take a position on the bypass petitions. The Alliance indicates that the court's May 3 order "inadvertently exclude[s]" it from the briefing schedule established therein and asks, as a party to the appeal, to "file briefs and participate alongside the other appellants, in accordance with the schedule included in the May 3 Order, and on the same terms as the Bypass Petitioners." The Alliance represents that it "conferred with counsel for all parties . . . and no party opposes the relief sought therein."

IT IS ORDERED that the unopposed motion for clarification is granted and that the court's May 3, 2024 order is amended to permit the Wisconsin Alliance for Retired Americans to file briefs and participate in the appeal in accordance with the same schedule and on the same terms
