Estrada v. Cir. Ct. for Milwaukee Cnty., L.C.#2020PR1174

On April 12, 2024, petitioner, Joe Salinas Estrada, pro se, filed a petition for supervisory writ. By order of April 16, 2024, the court, by its clerk's office, informed Mr. Estrada that this matter would be subject to dismissal unless, within ten days of the date of the order, the filing fee is received, or good cause is shown for waiving the fee by filing the petition for waiver of fees. By order of May 29, 2024, the court dismissed this matter because the filing fee or fee waiver petition was not received.

It appears that all documents mailed to Mr. Estrada in this matter have been returned to this court. The court attaches to this order copies of all documents previously sent to Mr. Estrada.

The court notes that since it does not appear that Mr. Estrada ever received the court's April 16, 2024 order, the May 29, 2024 dismissal order was issued in error.
