On May 14, 2024, Attorney Jill C. Vento, counsel for respondent-appellant-petitioner, J.S., filed a no-merit petition for review and appendix pursuant to Wis. Stat. § 809.32(4) regarding the court of appeals' April 16, 2024 decision. Along with the no-merit petition for review, counsel filed a motion for an extension of time for J.S. to file a supplemental petition for review pursuant to Wis. Stat. § 809.32(4)(a). On May 23, 2024, J.S., pro se, submitted a document that this court construed to be a motion to extend the time in which to file a supplemental petition for review pursuant to Wis. Stat. § 809.32(4)(a). On June 5, 2024, this court issued an order that granted Attorney Vento's and J.S's motions and gave J.S. until September 3, 2024, to serve and file her supplemental petition for review. The order also directed the clerk of this court to seal J.S.'s motion because she failed to comply with confidentiality rules applicable to termination of parental rights cases by using her full name when the use of initials or a pseudonym is required. See Wis. Stat. § 809.81(8).

On August 28, 2024, J.S. filed another pro se motion for an extension of time to file her supplemental petition for review. Again, her motion failed to abide by the confidentiality rules applicable to termination of parental rights cases in that it included her full name when the use of initials or a pseudonym is required. See Wis. Stat. § 809.81(1)(8). J.S. attached to her motion a hand-written note requesting access to the court's e-filing system.

On September 3, 2024, J.S. filed an additional pro se motion requesting an extension of time to not only file her supplemental petition for review, but also to "get proper on-line access and address my concerns with the clerk of court." This motion also does not comport with confidentiality rules as J.S. again signed the motion with her full name.

Based on the foregoing,

IT IS ORDERED that the motions for an extension are granted. J.S. shall have until November 4, 2024, to serve and file her supplemental petition for review pursuant to Wis. Stat. § 809.32(4)(a). No further time extensions will be granted; and

IT IS FURTHER ORDERED that the clerk of this court is directed to seal the August 28, 2024, and the September 3, 2024 motions filed by J.S., pro se. J.S. is reminded that her supplemental petition must comply with the confidentiality rules applicable to termination of parental rights cases, as described above; and,

IT IS FURTHER ORDERED that, for purposes of this case only, J.S. shall either file and server her supplemental petition by the traditional methods (i.e., via paper copies) or shall instruct Attorney Vento to electronically file the supplemental petition on her behalf.
