No. 2024AP180 & 181     State v. J.S., L.C.#s 2022TP64 and 2022TP65

On May 14, 2024, Attorney Jill C. Vento, counsel for respondent-appellant-petitioner, J.S., filed a no-merit petition for review and appendix pursuant to Wis. Stat. § 809.32(4) regarding the court of appeals' April 16, 2024 decision terminating J.S.'s parental rights to her children. Since that time, this court has granted J.S. two lengthy extensions of time to file a supplemental petition for review pursuant to Wis. Stat. § 809.32(4)(a). See orders of June 5 and September 5, 2024. In the last such order, this court gave J.S. until November 4, 2024, to serve and file her supplemental petition for review. The order warned J.S. that no further time extensions to file the supplemental petition would be granted.

On October 31, 2024, J.S. filed another pro se motion requesting a 120-day extension of time to file her supplemental petition for review. As was the case with her previous extension motions, J.S.'s latest extension motion does not comport with confidentiality rules applicable to

termination of parental rights cases, as she has signed the motion with her full name. Cf. Wis. Stat. § (Rule) 809.81(8).

IT IS ORDERED that the motion for an extension is granted in part. J.S. shall have 14 calendar days from the date of this order to serve and file her supplemental petition for review pursuant to Wis. Stat. § 809.32(4)(a). Absolutely no further time extensions will be granted. If J.S. does not serve and file her supplemental petition for review by this deadline, this matter will be disposed of based solely on the no-merit petition for review filed by Attorney Vento; and

IT IS FURTHER ORDERED that the clerk of this court is directed to seal the October 31, 2024 motion filed by J.S. J.S. is reminded that her supplemental petition must comply with the confidentiality rules applicable to termination of parental rights cases, as this court has explained in previous orders; and

IT IS FURTHER ORDERED that, for purposes of this case only, J.S. shall either serve and file her supplemental petition by traditional methods (i.e., via paper copies and pursuant to Wis. Stat. § (Rule) 809.80) or shall instruct Attorney Vento to electronically file the supplemental petition on her behalf.
