On October 8, 2021, Attorney James D. Rogers, Government Affairs Director, on behalf of the Wisconsin Association for Justice, filed this rule petition. The petition asks the court to amend Wis. Stat. § 804.03 to allow the remote administration of oaths at depositions. The court permitted remote administration of oaths at depositions as a temporary measure during the Covid-19 Pandemic. 1 By order dated

October 14, 2021, the court extended the temporary order permitting remote depositions until July 1, 2022. If this practice is to continue long-term, the court needs to formally amend the rule.

Consistent with standard practice, the court voted to solicit written comment. Letters were sent to interested persons on February 4, 2022. A comment in support of the petition was received from Attorney Cheryl Furstace Daniels, President, State Bar of Wisconsin, on behalf of the Board of Governors.

The court conducted a public hearing on April 11, 2022. Attorney Rogers and Attorney Amy M. Risseeuw, President, Wisconsin Association for Justice presented the petition to the court. Attorney Daniels, President, State Bar of Wisconsin, spoke in support of the petition.

The court discussed the petition at a closed administrative conference and voted to grant the petition. Therefore,

IT IS ORDERED that, effective July 1, 2022:

SECTION 1. 804.03 (4) (title), (a), (b), and (c), of the statutes are created to read:

804.03 (4) (title) REMOTELY LOCATED INDIVIDUALS.

(a) For the purposes of this section, an oath may be administered to a remotely located individual using audio-visual equipment. An officer administering an oath shall be in simultaneous communication with all parties to the deposition, whether or not in the physical presence of any of them. Remote administration of an oath at a deposition via audio-visual communications technology shall constitute the administration of an oath before a court reporter.

(b) Court reporters qualified to administer an oath in the State

of Wisconsin may administer an oath to a witness at a deposition

remotely via audio-visual communications technology from a location

within the State of Wisconsin provided the person administering the

oath can see and hear the witness and can identify the witness;

(c) If a witness is not located within the State of Wisconsin,

the witness may consent to being placed under oath remotely via

audio-visual communication technology by a court reporter qualified

to administer an oath in the State of Wisconsin.

IT IS FURTHER ORDERED that notice of the above amendments be

given by a single publication of a copy of this order in the official

publications designated in SCR 80.01, including the official

publishers' online databases, and on the Wisconsin court system's web

site. The State Bar of Wisconsin shall provide notice of this order.
