INSTRUCTIONS

Filing Requirements: SCR 20:1.15(i)(3) provides: "A law firm shall file one certificate on behalf of the lawyers in the firm who are required to file a certificate under par. 1. The law firm shall give a copy of the certificate to each lawyer in the firm." The partner or partners who are responsible for overseeing the firm's trust and fiduciary accounts should sign the Law Firm Certificate of Compliance and file it with the State Bar of Wisconsin, along with the dues statements of each lawyer in the firm.

NOTE 1: Only the original Law Firm Certificate of Compliance should be filed with the Bar. Do not attach a copy of the Certificate to each dues statement.

NOTE 2: Trust and fiduciary accounts and safe deposit boxes opened after submitting this Certificate should be reported on next year's Law Firm Certificate. However, Overdraft Notification Agreements must be filed with OLR at the time any new draft-type trust or fiduciary account is opened, unless the account is a fiduciary account that is subject to one of the alternative protection procedures in SCR 20:1.15(j)(9).

Penalty for Non-compliance: Pursuant to SCRs 20:1.15(i)(4) and (j)(10), failure to complete the trust account certificate is grounds for automatic suspension from the practice of law in the same manner as for nonpayment of dues.

Accounts subject to Reporting: In an April 11, 2001 Order, the Wisconsin Supreme Court specified that: "A lawyer must certify all trust accounts and safe deposit boxes in which the lawyer deposits clients' funds or property held in connection with a representation or held in a fiduciary capacity that directly arises in the course of or as a result of a lawyer-client relationship."
