## Wisconsin Supreme Court accepts one case at August 1 conference

**Circuit Court:** Racine County, Judge Eugene A. Gasiorkiewicz, *reversed and remanded with directions*.

**Long caption:** Hayden Halter and Shawn Halter, Plaintiffs-Appellants, v. Wisconsin Interscholastic Athletic Association, Defendant-Respondent-Petitioner.

### Issue(s) presented:

1. Is the WIAA a state actor?
2. Are the Halters entitled to judicial review of the WIAA's decision to suspend Hayden Halter from the 2019 varsity wrestling regional event and to deny him an internal appeal to the body's Board of Control?
3. Are the Halters entitled to certiorari relief?

4. Are the Halters entitled to declaratory relief reinstating Hayden Halter's 2019 state title and points?

5. Are the Halters entitled to a permanent injunction?
